

Participation and disclaimer agreement

I, the undersigned _____ born in _____ prov. _____ on _____

Accept the following terms and conditions for participation at the road race called "ELECTRIC TRAIL"

1. Description of the activities.

1.1. I accept to run as an athlete the specific route indicated by the organisation and only that route.

1.2. I am aware of the risk of being injured during my participation at the Trail organised by THERMOPLAY TEAM. By signing this agreement, I assume this risk and all the other risks indicated hereafter. The signing of this document, without alterations, cancellations and/or modifications, constitutes the essential condition for my participation at the ELECTRIC TRAIL, as an athlete.

2. Accepting risks.

2.1. I am aware and accept that during my participation as an athlete at the ELECTRIC TRAIL risks of various nature can arise for my safety and/or for my personal belongings and that these risks cannot be indicated beforehand by THERMOPLAY TEAM and/or by third parties designated for this purpose and that, even if these risks are indicated by THERMOPLAY TEAM or by third parties designated for this purpose or, should THERMOPLAY TEAM or these latter provide me with safety equipment, my safety could still not be guaranteed.

2.2. I promise to keep THERMOPLAY TEAM promptly informed if, before my participation at ELECTRIC TRAIL, I become aware of pathologies or medical ailments which could impair and/or make my participation difficult and/or dangerous.

2.3. I accept, fully in possession of my mental faculties, that THERMOPLAY TEAM will not be liable for any damage or loss which could occur to my person and/or my personal belongings which I carry with me during ELECTRIC TRAIL in any way whatsoever, even after having carefully followed the instructions and directives of THERMOPLAY TEAM. .

2.4. I expect to arrive at the meeting point for athletes communicated by THERMOPLAY TEAM and to respect the timetable I have received; I accept to personally provide for my transfer, with the transportation means I deem most suitable, taking all responsibilities to and from the meeting point.

3. Permission for medical treatment.

3.1. If, during my participation at ELECTRIC TRAIL, I should suffer any type of injury and should I at that moment lose consciousness, fully in possession of my mental faculties, I authorize from this moment health personnel in charge to provide me with required first aid assistance.

4. Processing of personal data and permission for use of name and image.

4.1. I permit my personal and sensitive data to be gathered and processed in compliance with D.Lgs. n. 196/2004 es.m.i., by THERMOPLAY TEAM and by third parties designated by the Organisation committee for the sole purposes linked to my participation as an athlete at the ELECTRIC TRAIL.

4.2. I give my consent at this moment to THERMOPLAY TEAM, to the Organization committee and to third parties authorised by them, to be photographed and/or filmed and/or recorded. THERMOPLAY RUNNING RACE, the Organization committee and third parties authorised by them will have the faculty of transmitting, publishing, certifying and using any photograph, video, recording or image which depicts me, without my requesting any compensation and without any limit. The Organisation committee, THERMOPLAY TEAM, third parties authorised by them and whoever acquires from the latter the right to use this photographic or video material will not be retained responsible towards me for any use of this material.

4.3. The registration of images or sounds of the competition performed by myself or on my behalf with any type of audio or video equipment can be used exclusively for private and domestic purposes. Thereby I pledge not to sell, certify, transmit, publish or perform any type of commercial use in general of the aforementioned recordings and/or images and not to exploit my participation at the trail commercially in any way and with any means.

4.4. I promise not to make use of alcohol or performing enhancing drugs during my participation at the competition.

5. Truth of declarations.

I assume all civil and penal liability deriving from any false or incomplete statements declared and/or signed by myself to THERMOPLAY TEAM and/or to third parties designated for this purpose concerning my participation at ELECTRIC TRAIL as an athlete.

6. Waiver and Discharge.

I discharge THERMOPLAY TEAM and the Organisation committee and third parties designated by them (including respective administrators, managers, employees, collaborators, consultants, suppliers, agents and volunteers) from all and any liability for any damage, loss or injury, even fatal, that I or my belongings may suffer during my participation at the race, for whatever cause it may be, even in the event negligent conduct of the above-mentioned discharged subjects, within the limits set down by law. I commit to retain THERMOPLAY TEAM and the Organisation committee and third parties designated by them (including respective administrators, managers, employees, collaborators, consultants, suppliers, agents and volunteers) relieved from all and any liability, including any legal fees, for claimed damage, loss or injuries caused to third parties and/or to property due to my conduct.

7. Respect for these conditions.

By signing this Agreement, I accept to participate as an athlete at the competition committing to respect these conditions, directives and decisions of the THERMOPLAY TEAM and of the third parties designated by them regarding the event. My participation at ELECTRIC TRAIL as an athlete is expressly subordinated to the condition that I do not damage the tranquillity and safety of third parties, or the interests, image and reputation of THERMOPLAY TEAM, and of the Organisation committee.

8. Validity.

Should any of the provisions of these terms and conditions be invalid, the other provisions will continue to have full effect. Read and approved.
